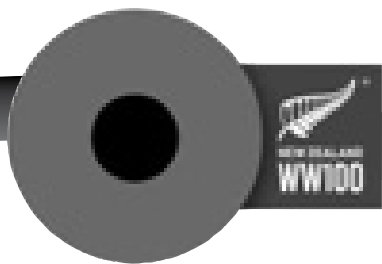

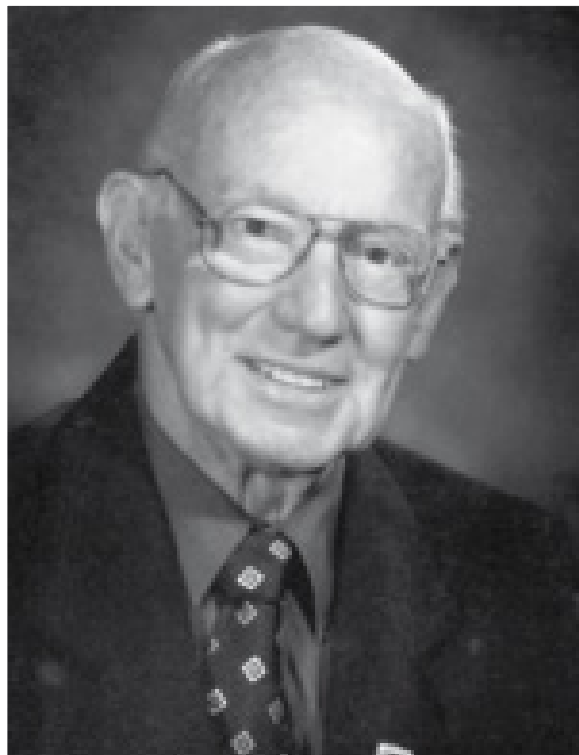

Ron Boyles – Club Man

The passing of Ron Boyles saw the passing of a true club man.



A Life Member from 2007 till his death in June 2014, Ron was the embodiment of what the true clubs movement stands for.

As Club Treasurer 1994 – 1996, he had an active part in the re-siting of Hamilton Workingmen's Club from Harwood Street to its present address, where the club has expanded and progressed to such an extent, it is now one of the biggest and best clubs in New Zealand.

Ron was a man of style and impeccable taste. Always a fastidious dresser, he presented as a man who took a pride in his appearance at all times. He was a man's man, but always the perfect gentleman.

Club Patron Colin Sullivan relates his first contact with Ron was as a small boy, when Ron was a Road Services bus driver on the Taumarunui - Hamilton run. Ron would call in at the Mapu general store run by Colin's aunt and uncle. It was the start of a friendship that was to last until Ron's death.

Ron worked for many years for Fairview Motors in Hamilton, and at one stage he was on the road selling marine motors and accessories, becoming a well-known sight in the provinces in his purple

XY Falcon ute. Surely a collector's item now if it is still around! In later years, after he retired from the active work force he continued to work for Fairview Motors as a co-ordinator for drivers who picked up and delivered cars. Many of these drivers were recruited from the Club and the group became known as Dad's Army.

Ron had a great interest in aviation. At one stage he held a pilot's licence and owned his own small plane. His car number plate was BERB – his initials. He was a keen snooker player. He had a liking for red wine. He was a loyal friend and club member, taking an interest in the staff, who held him in high regard.

A quiet but lasting legacy Ron left is a board on the wall of the Club, to the right-hand side of the exit door into the main foyer. It is a map of New Zealand, with a badge and name for every Clubs NZ member club in the country. Ron put this together some years ago – and like the man, it is presented impeccably and correctly.

Melbourne Cup 2014

Winners are grinners! There were plenty of winners at the Hamilton Workingmen's Club on Melbourne Cup day!

From the Fashion in the Field through to the 320 people who invested their \$10 in the punters club.

Waikato Times correspondent and Guest Tipster Kevin Fly turned the punters club's \$10 into a \$23 collect at the end of another fanciful, glamorous day.

"The punters club was holding its own prior to the Melbourne Cup and so Kevin went hard with a \$1000 punt on the favourite Admire Rakti," said TAB manager James Cunneen, "plus a few other bets on the Cup which came unstuck," he added.

Their big bets on the Melbourne Cup won by the German owned and trained galloper Protectionist, over perennial Cup place getter Red Cadeaux and Who Shot Thebarman, the New Zealand-owned and trained by former Kiwi Chris Waller galloper, did not come to fruition – Admire Rakti came last!

"But like a phoenix rising – Kevin really liked a horse in the race following the Cup at Flemington which saw the punters club strike gold," said Cunneen.

Atacama, bred by Sir Peter Vela from Pencarrow and trained at Cambridge by Shaune Ritchie and ridden by former Cambridge jockey James McDonald, stormed to success and therefore helped to turn the fortunes of the Punters Club from the graveyard to the gold mine.

And there was further success – not just on the racetrack.



There were opportunities for all who attended with Sharon Lonsdale winning the best-dressed award for the fillies, while for the colts Stu Campbell was awarded the best dressed on the day. Racing was very much a hobby but now James felt another calling and from working part-time in TAB outlets he grew to become a respected manager, horse owner and breeder.

One of his many highlights was recorded in 2008 when he managed “Young Centaur” for the owners Soon Shiong and John Sargent and won the Wellington Cup (the jockey was Michael Walker).

James currently has 2 brood mares (One Nite Stand and Novice Mistress), one horse racing and 8 young horses ready to go into work.

James has always recognised people who help themselves and others and has donated a trophy to the FJBC, for a sponsored tournament, to recognise a long-standing friend and Matamata punter – Annie Bell.

Policy for Minimising Risk of Problem Gambling, Identifying Problem Gamblers and Minimising Risk of Underage Gambling at its Premises.

Problem Gambling

1. A problem gambler is a person whose gambling causes harm or may cause harm.
Harm –
 - a. means harm or distress of any kind arising from, or caused or exacerbated by, a person's gambling; and
 - b. includes personal, social, or economic harm suffered –
 - i. by the person; or
 - ii. the person's spouse, partner, family, whanau, or wider community; or
 - iii. in the workplace; or
 - iv. by society at large.
2. Problem gambling can be described as occasional or regular gambling to excess to the extent that it leads to problems in other areas of life, particularly with finances and inter-personal relationships. These problems range from minor ones involving, for example, arguments with the family over gambling expenditure, to problems involving a compulsive addiction to gambling resulting in major financial or inter-personal difficulties.

Problem Gambling Policy

3. Brochures and notices will be displayed in the gaming area. The brochures and notices inform players about the hazards of gambling, encourage players not to spend more than they can afford, and set out information on assistance for gambling problems.
4. The gaming machines operated do not have banknote acceptors that accept notes higher than \$20.00 in denomination.
5. The Club's staff at the Venue are instructed to limit EFTPOS cash out requests from customers who are playing the machines to a maximum of \$20.00 per transaction.
6. Credit is not provided by the Club or person representing the Club.
7. The Club's staff at the Venue shall prevent customers showing signs of intoxication from playing gaming machines and will request they leave the premises if necessary.
8. A clock is prominently positioned in each gaming area.
9. No syndicate play is permitted.

Policy for Identifying Problem Gamblers

10. The Venue Manager is required to participate in training to keep up to date with procedures for identifying problem gamblers and the problem gambler intervention process.
11. A person will be identified as a potential problem gambler if any of the following indicators are present:
 - a. the person remains in the gambling area for excessively long periods (three hours or more);
 - b. the person has a high number of gambling sessions per week;
 - c. within the three hour timeframe, the individual makes repeated requests to obtain cash out from an EFTPOS terminal or makes three or more visits to an ATM machine;
 - d. the person is unaware of the length of time they have been gambling;
 - e. the person expresses signs of anger or distress while gambling;
 - f. the person has arguments with other players or venue staff i.e. disorderly/agitated behaviour;
 - g. the person causes damage to the gaming machine;
 - h. the person attempts to cash cheques;
 - i. the person attempts to borrow money onsite;
 - j. the person attempts to play two or more machines;
 - k. the person drinks to excess while playing the gaming machines and starts to show signs of intoxication;
 - l. the person falls asleep in the gaming area;
 - m. where information is received that the person has received an exclusion order from any other Class 4 Venue;
 - n. information is received from family or friends of the individual expressing concern that the person is:
 - i. gambling excessively;
 - ii. possibly obtaining funds illegally for gambling;
 - iii. using money for gambling which has been budgeted for other expenditure; or
 - iv. has left children without adequate supervision while present in the gaming area.
 - o. Any indication that the person is seeking to borrow money in order to win back losses or continue to gamble.

12. Venue staff will report any observed gambling behaviours that cause them concern. On-venue staff will relay their concern to the Venue Manager.
13. If a problem gambler is identified, the Venue Manager shall approach the person concerned and offer information and advice to the person about problem gambling. The Venue Manager should approach the person in a polite manner and ask to speak to them privately, in a separate, discrete area. Patrons shall at all times be treated with respect, sensitivity and a willingness to help. The Venue Manager will then:
 - a. provide information to the player about the characteristics of problem gambling (including recognised signs of problem gambling);
 - b. remind the player that the gaming machines take more money from gamblers than they pay out;
 - c. provide advice on the odds of winning;
 - d. advise the player of the potential risks and consequences of problem gambling;
 - e. tell the player how to access problem gambling services;
 - f. explain the self exclusion procedure including reminding the player that under the Gambling Act 2003:
 - i. a player can "self-identify" as a problem gambler and ask the venue to exclude them from the gambling area for up to two years; and
 - ii. management has the right to identify a person who they believe is a problem gambler, and ban them from the gambling area for up to two years.
14. The Club's Venue Manager must issue an exclusion order to self identified problem gamblers.
15. Unless the Venue Manager has good reason to issue an exclusion order for a lesser period, the exclusion period specified in the order shall be a minimum of 3 months. Once issued, the exclusion order cannot be revoked, rescinded or withdrawn. Exclusion orders issued under the Gambling Act restrict entry to the gaming area of a venue only. They do not restrict entry to the entire venue.
16. Venue staff must remove excluded persons who attempt to re-enter the gambling area. Failure to remove an excluded person is a criminal offence punishable by a fine of up to \$500.00.

Policy for Minimising Risk of Underage Gambling

17. Entry to the Clubrooms (ie the Venue) is restricted to members of the Club and guests of members who are accompanied by a member. A swipe card and sign-in system is in place to ensure compliance with this restriction.
18. All gaming machines must be located in a separate, defined area of the Venue.
19. The gaming area must be under regular supervision by the Venue staff.
20. A sign shall be placed at the entrance of the gaming area advising that it is an offence for persons under 18 years of age to play gaming machines.
21. The Club's staff at the Venue will receive information outlining the age restrictions and the ability to request persons under 18 years of age to leave the premises.
22. The Club's staff at the Venue will ask any individual who looks 21 years or under and enters the gaming area for photo identification to verify their age.
23. Any person who fails or refuses to provide photo identification shall be asked by the Venue Manager to leave the gaming area and not re-enter the gaming area.
24. The Venue Manager will issue a trespass notice to any individual who is found to be under 18 years of age playing the gaming machines.
25. All the Club's staff at the Venue will refuse to pay prize money to any person who looks under 21 years of age and refuses to produce photo identification confirming that they are 18 years or older. The prize money shall be held along with details of the individual's name, address and the date the prize was won. The prize shall be held for 7 days and paid to the individual if photo identification is provided confirming that the individual is 18 years or older. If suitable identification is not provided within 7 days, then the funds shall be banked into the Club's gaming account.

The Changing of the Goals

What do 18 club titles, an Oceania coaching certificate and a NZ coaching position have in common?

They all relate to at least one of the celebrated football (soccer) players who are or have been members of the Frankton Junction Bowling Club.

DAVE WALLACE: Dave was born and raised in the Hillcrest area. He played football from an early age.

He gained Waikato selection in the Under 12, 14, 16 and 21 teams and went on to secure his blazer while playing for the senior team.

Dave was a member of the under-14 team that went on to win the national title and was selected for an invitational team to play Australia at Seddon Park in 1964. (He also played in a team selected to play the great Tom Finney who had 76 appearances for England).

After breaking his leg at an early age Dave was introduced to bowls by his father and eventually he joined the Hillcrest Club.

As a bowler Dave has already amassed 2 Waikato titles, 2 Clubs NZ titles and 18 club titles (FJBC and Hillcrest).

DAVE HALL: Dave was born in England (Bexhill – on – Sea) and played for Sidley United and the Royal Air Force team.

After landing in Hamilton in 1974 Dave was very quickly snapped up as a coach and he eventually secured a position with Ngaruawahia, taking the team from Waikato's 4th Division to the Northern League 1st division in 8 years.

Having completed his F.A. and Oceania coaching qualifications, the following years saw him coaching Melville, Claudelands and Wanderers, where he had another 8 year stint.

They joined FJBC in the 1995/1996 season and quickly became respected players.

Dave gained 9 club titles and he and Sylvia combined to win the Waikato Champion of Champions Mixed Pairs title in the 2002/2003 season.

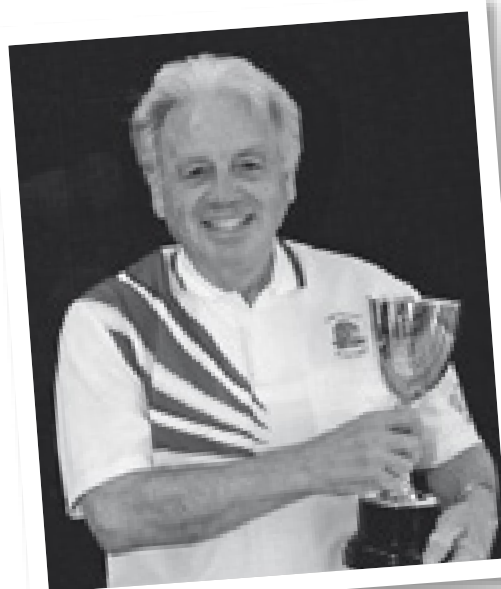
Dave passed away in 2007 but left behind a legacy of team work and commitment.

JEFF COULSHED: Born in England, Jeff made a name for himself playing for Skelmeres Dale football club.

Jeff arrived in NZ in 1963, played for Waikato in 1964, later secured a professional contract with Hakoah in Sydney, then Macedonia in Melbourne before returning to Waikato in 1967.

Although Jeff loved playing, he very quickly became ranked as an exceptional coach.

After coaching Ngaruawahia to the semi-final of the Chatham cup, Hamilton to the Northern league title and the Waikato men in the national league, Jeff realised that his playing was being hampered and so he changed his allegiance to coaching women.

Bowlers could note that Jeff coached Jo Edwards and Val Smith (world ranked NZ bowlers) in the NZ football age group competition.

Jeff coached the Waikato Women's team to consecutive national titles in 1989 and 1990 and he went on to be appointed NZ coach in 1995 taking the team to India to play highly ranked South American teams.

Jeff was introduced to bowls when Dave Hall invited him to play in the HWMC business competition and he has since gone from strength to strength by winning the FJBC "Most Improved Player" Trophy in the 2013/2014 season.

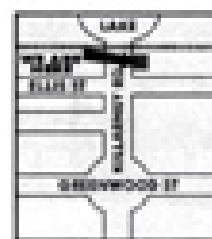

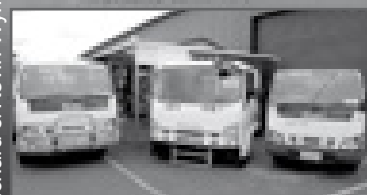

When I mentioned to our visitors, from Wellington, Christchurch and Dunedin, that we had 14 Sub-sections in the Club, they could not believe how fortunate our Club Members were to have such a great facility. 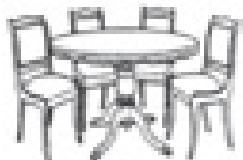

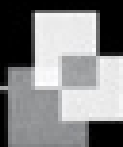

Host Responsibility Policy

Patrons who are visibly intoxicated will not be served alcohol. Alternatives will be offered including food, water, tea and/or coffee. Staff are trained to recognise signs of intoxication and practical interventions. Staff are instructed to not serve alcohol to patrons they suspect are becoming intoxicated either directly or indirectly through friends.

Patterns of drinking will be closely monitored. Stockpiling, boat races, drinking challenges or over zealous cocktails will not be allowed as they invariably lead to intoxication.

We promote the use of alternative transport. The Club operates a fully licensed Courtesy Bus service. Dial a driver services are available. Phones are available free of charge for arranging alternative transport. Staff may request the surrender of car keys should this be deemed necessary.

We expect all patrons to conduct themselves in an orderly and proper manner at all times. If patrons spoken to do not adhere to our requests then we will ask and insist that they leave the premise immediately. Failure to comply may jeopardise future entry.

TRIBUTE TO DECEASED MEMBERS:

A moment of silence was observed as a tribute to members who had passed away during the year.

PRESIDENT'S REPORT AND FINANCIAL STATEMENTS:

B Simpson started his address to the members by mentioning that he hoped they had all received their yearbook publication and had read his report. The financial statements for the year have been effected by the recession but to a lesser degree than a lot of our counterparts. A lot of the industry sector, particularly Clubs, are genuinely struggling and some will cease to exist fortunately we are not one of those Clubs. The redevelopment of the building situated at 26 King Street, which was lost to fire, was subject to motion last year. It has only been with some prudence in mind that we have not begun this redevelopment although it was approved by the general membership. We have had a QS report that tells us that a significant amount of money would

be required to redevelop in its entirety the way that we have depicted it. We are currently working through a process whereby we determine how we go about the redevelopment and it is likely to be in a stage by stage situation where stage one would be the construction of a useable shell but not complete in its entirety. To do this we would use only the money readily available through the insurance proceeds without committing the Club to significant borrowings which would be inappropriate right now. B Simpson stated that there was nothing sensational to report regarding the financials. There was a small book loss. He reiterated that these are genuine Profit & Loss accounts losses that we show after allowance of depreciation. Our cashflow is positive to the tune of several hundred thousand dollars. Balance sheet, in terms of worth of assets at cost less depreciation, is down slightly on the previous year due to the depreciation. Liabilities have also reduced. Our positive cashflow has been used to keep the debt that we have in check. Members can look forward to the Hamilton Workingmen's Club moving into the next year with a lot of positive things happening and a far more secure situation than most of our counterparts. He is pleased to report that our accountants and bankers are pleased with our financials and we have, once again, received an unqualified auditors reports from our auditors. B Simpson asked if P Lee (Treasurer) had anything to add.

P Lee stated that the financial accounts still hold one concern for him and that is the decrease in bar turnover. He reiterated his suggestion from last year that people encourage more of their friends and families to join and utilize all facets of the Club.

B Simpson agreed with P Lee statements and stated that although people may have less to spend it would be good to get more people through the doors and using the Club.





1 Statement of Accounting Policies

Reporting Entity

Hamilton Workingmen's Club (Inc) is a chartered club incorporated under the Incorporated Societies Act 1908. The club provides recreational facilities as a fellowship and social club for the use and welfare of its members. The financial statements of Hamilton Workingmen's Club (Inc) are special purpose financial statements.

Statement of Compliance and Basis of Preparation

The financial statements of Hamilton Workingmen's Club (Inc) have been prepared in accordance with the stated accounting policies.

The special purpose financial statements do not comply with New Zealand generally accepted accounting practice (NZ GAAP). Whilst these special purpose financial statements have been prepared applying the framework provided by NZ GAAP, they depart from the requirements of NZ GAAP where impairment losses on property, plant and equipment, compensation from insurance claims and adjustments to prior year Tertiary Education Commission liability have been recognised through equity. Under NZ GAAP, impairment losses of property, plant and equipment compensation from insurance claims and adjustments to prior year Tertiary Education Commission should be recognised through the Statement of Financial Performance.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of the Statement of Financial Performance and Statement of Financial Position have been applied:

(a) Revenue

Revenue is recognised on an accruals basis.

(b) Stock on Hand

Inventories are recognised at lower of cost and net realisable value, determined on a first-in first out basis. There is no damaged or obsolete stock.

(c) Trade Receivables

Trade Receivables are recognised at estimated realisable value.

(d) Property, Plant & Equipment

Property, Plant & Equipment are recognised at Cost less aggregate depreciation. Depreciation has been calculated using the rates permitted by the Income Tax Act 2007. Gains and losses on disposal of fixed assets are taken into account in determining the operating result for the year.

(e) Income Tax

No liability from income tax arises on the basis that the Club is a non-profit entity that trades within the circle of its membership.

(f) Goods and Services Taxation (GST)

Revenues and expenses have been recognised in the financial statements exclusive of GST. All items in the Statement of Financial Position are stated net of GST except for receivables and payables which are stated inclusive of GST.

(g) Comparatives

Certain comparative information has been reclassified in order to provide a more appropriate basis for comparison.

(h) Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on a basis consistent with those from previous financial statements.

13 Term Liabilities

The club has granted a registered first mortgage in favour of the ANZ Bank over its land and buildings. As at balance date borrowings in respect of this liability totalled \$231,156 (2014: \$155,307).

The club has granted a registered first mortgage in favour of the ANZ Bank over the property at 25 Commerce Street, Hamilton and 26 King Street, Hamilton. As at balance date the borrowings in respect of this liability totalled \$227,347 (2014: \$284,910), \$355,347 (2014: \$438,773), 1,257,038 (2014: \$1,256,487) \$502,815 (2014: \$502,594) and \$14,276 (2014: \$37,513) respectively.

The current portion of term liabilities relates to principal that is to be repaid within the next financial year. ANZ Bank Term Loans 1007 and 1008 are due to mature in October, 2015. It is the Club's intention to roll these loans over and the bank have provided indicative confirmation that this will be carried out.

The ANZ Bank line of credit is repayable on demand, however, it is not anticipated that the loan will be repaid in the next year. Interest is reviewed every 90 days - finance rate plus margin of 1.75%.

The NZ Breweries marketing loan is repayable over 5 years. The club has granted a General Security Deed to NZ Breweries and a Deed of Priority listing as NZ Breweries as second secured creditor.

The DB Breweries marketing loan is repayable over 5 years but if requested is repayable on demand.

The Equipment Finance Ltd Hire Purchase loan is for computer servers (3) and is repayable over 3 years.

14 Financial Instruments

Financial instruments which potentially subject the entity to credit risk consist of bank balances.

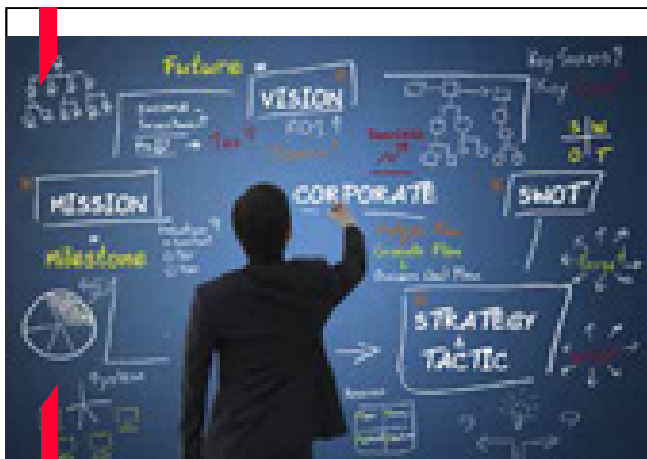
