He also led in a number of leading environmental cases, including Fast Ferries, the Transpower HVDC upgrade inquiry, and Contact Energy's Hauāuru Mā Raki'wind farm inquiry. His judicial decisions include *Marlborough DC v Franklin* (2013) on existing use rights, *Horticulture NZ v Manawatu-Wanganui RC* (2013) on the "One Plan" appeals, and *Palmerston North CC v Motor Machinists Ltd* (2013) on plan change procedure.



#### Maree Baker-Galloway, Anderson Lloyd, Dunedin

Maree is a partner in Anderson Lloyd's resource management team, with particular expertise in water, biodiversity, mining, tourism and the Conservation Act.
