CHAIR



The Hon Justice Simon France, High Court, Wellington

Justice Simon France graduated LLB (Hons) from the University of Auckland and undertook overseas study (LLM Queen's University, Canada). In 1984 Justice France joined the Law School at Victoria University of Wellington where he taught and wrote in the areas of criminal law, administrative law and the law of evidence. In 1995 he moved to the Crown Law Office where he specialised as an appellate advocate in criminal cases, before becoming team leader of the Human Rights team. Justice France was appointed to the High Court in January 2005 and is based in Wellington.

The Hon Justice Terence Arnold, Supreme Court, Wellington

Having taught at law schools in Canada and New Zealand, Justice Arnold joined Chapman Tripp in 1982 and was a partner from 1985-1994. In 2000 he became Solicitor-General and in 2006 was appointed to the Court of Appeal. Justice Arnold has taught, written and presented seminars in a variety of areas and has been active in the development of skills-based training for litigators.

He was counsel for one of the "Urewera 4", and was recently counsel for two teenagers (*R v D Smith & R v Te Wini*) who had their murder convictions quashed by the Court of Appeal (one of whom was acquitted of murder at his retrial). Christopher is also counsel in a case currently before the Supreme Court regarding party liability jury instructions in multi-accused murder trials (judgment reserved). He is a long-standing international member of the American defence lawyers association.
