### The Hon Justice Denis Clifford, High Court, Wellington

Justice Denis Clifford graduated LLB (Hons) from Victoria University of Wellington in 1978. He joined the Wellington law firm Buddle Anderson Kent & Co, leaving in 1980 to take up a position as Visiting Fellow at the University of Illinois Law School. Justice Clifford returned to New Zealand to work for Buddle Findlay becoming a partner in 1986.
