Environment Judge John Hassan, Christchurch

Judge Hassan was the Deputy Chair to the Independent Hearings Panel for the Christchurch Replacement District Plan. Prior to his appointment, he was a partner in Chapman Tripp specialising in resource management and environmental law. In that capacity, he represented government agencies, industry, local government and community groups before Councils, the Environment Court, Boards of Inquiry and the High Court in relation to major infrastructure works, plan changes and consent and appeal hearings. He has a significant background in law reform and law drafting and in public law. In 2009, he was appointed as a panel member by the Local Government and Environment Select Committee to audit and advise on the drafting of the Resource Management Amendment Act 2009 and he was a reference group member advising the Environment Minister on RMA reform proposals in 2011. He is the founding co-author of Brookers Resource Management.



Environment Judge David Kirkpatrick, Auckland

Judge Kirkpatrick is an Environment Court Judge, having been sworn in on 3 February 2014. The Judge is an Associate of the Arbitrators and Mediators Institute of New Zealand and a member of the Resource Management Law Association.

He was the first Chair of the Environmental Legal Assistance Advisory Panel and is an Honorary Life Member of the Resource Management Law Association; and the New Zealand Legal Research Foundation. He is an Honorary Fellow of the Environment Institute of Australia and New Zealand. In the 2001 New Years' Honours List he was appointed a Companion of the New Zealand Order of Merit for his services to Environmental Law and in 2016 he was awarded an Honorary Doctorate of Natural Resources by Lincoln University
