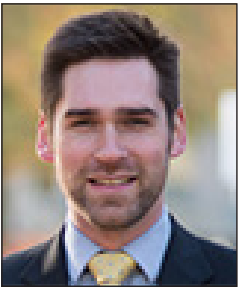


PRESENTERS
