Professor Jeff Berryman, Faculty of Law, University of Windsor, Ontario

A former Dean of the Faculty, Jeff teaches contracts, remedies, and restitution. He is the author of *The Law of Equitable Remedies* and co-author of the leading remedies casebook *Remedies: Cases and Materials*. Jeff has published widely in the area of remedies and has taught and given seminars on the subject in the UK, Australia, NZ, and the US.
