
The Hon Justice Winkelmann, Chief High Court Judge

Justice Winkelmann was admitted in 1985, was a partner at Phillips Fox from 1988 and in practice as a barrister sole from May 2001. Justice Winkelmann was appointed a High Court Judge in July 2004 and appointed as Chief High Court Judge in September 2009 with effect from 1 February 2010.



The Hon Justice Asher, Auckland

Justice Asher was a partner at Kensington Haynes & White and Kensington Wallace, (later Kensington Swan) from 1976-86, and in 1986 commenced practice as a barrister. He was appointed Queen's Counsel in 1992 and to the High Court in 2005. He is a past President of the NZBA and ADLS and Vice-President of NZLS.



The Hon Justice Fogarty, Christchurch

Justice Fogarty practised in the firm of Weston Ward & Lascelles in Christchurch between 1974-1985, becoming a partner in 1978. He became a barrister sole in 1985, was appointed Queen's Counsel in 1990 and was appointed a High Court Judge in 2003.



The Hon Justice Miller, Wellington

Justice Miller first practised in the Alexandra firm of Bodkins Solicitors from 1981 and joined Chapman Tripp Wellington in 1984, becoming a partner in 1987. He was appointed to the High Court Bench in 2004.
