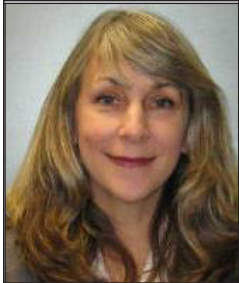
### **Michael Hargreaves, WorkSafe New Zealand, Wellington**
