#### Sylvia Bell, Human Rights Commission, Auckland

Formerly the senior legal officer at the Office of the Race Relations Conciliator, Sylvia is the general editor of Brookers *Human Rights Law* and a contributing author of the section on the Human Rights Act. She is the co-author of Brookers *Family Law – Incapacity and Mental Health Law in New Zealand* which received the JF Northey Memorial Award for legal writing.

# Charles Chauvel, Regulations Review Committee, New Zealand Parliament, Wellington
