### **Stephen Tomlinson, Tomlinson Law, Christchurch**

### **Graham Tubb, Inland Revenue Department, Wellington**

Graham is Group Tax Counsel and leads the Legal and Technical Services group (part of Investigations and Advice) at the IRD. The LTS group is one of the principal technical units within Inland Revenue, and is charged with ensuring that all parts of Service Delivery receive competent professional advice on the revenue legislation, resolving emerging issues, and ensuring that certain key processes have been correctly applied. In addition the group sets standard practices relating to many of the Commissioner's powers. Graham joined Inland Revenue in 2003, prior to which he was a tax and corporate partner at Kensington Swan. Some of the key projects he has worked on include the department's approach to care and management, the use of the Commissioner's search powers, the practical application of the tax avoidance rules, shortfall penalties, the disputes rules including facilitated conferences, and the merger of several earlier groups to form LTS. He is part of the management team of Investigations and Advice, and a member of the department's Technical Governance Committee, National Disputes Committee, and several other governance groups.
