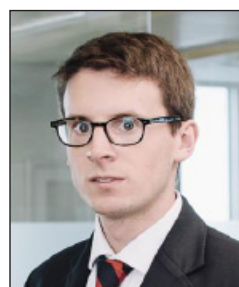
Andrew Skelton, Barrister, Wellington
