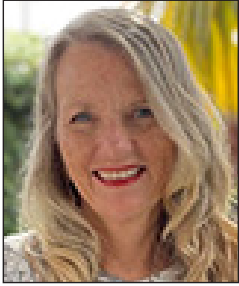


## PRESENTER
