Jack Hodder, Chapman Tripp, Wellington

Jack joined Chapman Tripp in 1991 having practised as a barrister for 11 years. He practises in all aspects of corporate, commercial and public law litigation and in arbitration. Jack was an inaugural member of the NZ Law Commission between 1986 and 1991, and the founding editor in 1978 (and still a co-editor) of *The Capital Letter*.

The Rt Hon Sir Geoffrey Palmer, Chen Palmer & Partners, Wellington

Sir Geoffrey Palmer is a former Prime Minister, Attorney-General, Minister of Justice and Leader of the House. He was an MP from 1979 until 1990. He has taught constitutional law in New Zealand for many years at Victoria University of Wellington where he was formerly a professor and is now an honorary lecturer. He also teaches comparative constitutional law at the University of Iowa in the United States. In 1994 Sir Geoffrey founded New Zealand's first specialist public law firm with Mai Chen and he remains a consultant to that firm. He is Chair of the Legislation Advisory Committee and is New Zealand's Commissioner to the International Whaling Commission. Sir Geoffrey has written 12 books and more than 40 law review articles.

The Rt Hon Sir Ivor Richardson, Wellington

Sir Ivor Richardson retired as President of the Court of Appeal in 2002 after 25 years as an appellate judge. Since then he has focused on tax matters and on the roles and relationships of the three branches of government, including Bill of Rights questions. Sir Ivor has recently sat on the Supreme Court of New Zealand and the Hong Kong Court of Final Appeal.
